Circular to all members,

With extreme pleasure and deepest satisfaction we would like to inform our members that our Foundation Conference & General Body Meeting was held in Bengaluru on Sunday the 29th May 2022 as per the notice dated 25.04.2022 issued by the General Secretary on behalf of the Central Committee of BOBWO.

#### **Delegates / Business Session**

The Delegate Session of the Conference started at 9.30.a.m. About 700 delegates participated in the Session. Apart from the delegates/invitees representing various Regions our All India leaders viz. om. Janak Rawal, Com. S P Sharma, Com. S D Srinivasan, Com. Manohar Karkera, Com. M V Patil, Com. Ajay Kumar were also present in the Delegates' Session and witnessed the proceedings. Com. Dasaiah Gowda, our President, after welcoming the delegates, leaders and all other participants to the meeting took up the following agenda.

#### **Condolence Resolution**

The meeting condoled the death of various personalities from last 2 years in the Trade Union and other fields including Com. Amritlal, General Secretary, AlBOBECC, Com. Ajay Manjrekar, General Secretary, KPBEF, Com. K J R Reddy, Vice President, KPBEF and several other leaders at National level, persons who died out of COVID-19 Pandemic, people who died due to Natural Calamities like flood etc. Meeting also paid its deepest respect to the departed souls by standing with a minute's silence.

### Report of the General Secretary

Com. Mallesha M C, General Secretary presented a brief report on the activities of the Union particularly after the merger of Dena Bank and Vijaya Bank with Bank of Baroda on 01.04.2019. He also touched upon various stages of unification of VBWO and DBEU culminating with emerging of BOBWO (Kar). The report presented by him was also circulated to the delegates / participants. The report of the General Secretary was approved by the delegates unanimously.

#### Financial accounts of the BOBWO.

Com. Suresh Babu, Treasurer has placed financial accounts of the Union for the years 2020 and 2021 before the General Body. The printed accounts were also circulated among the delegates. The meeting unanimously approved the accounts.

#### Amendment to the Bye-laws/Approval/Resolutions

The General Body unanimously approved the Bye-laws of the BOBWO, Karnataka, the draft of which was circulated among the delegates. Com. S D Srinivasan, Dy. General Secretary, AIBOBECC placed and clarified certain points on the draft Bye-laws with amendments and thereafter the same was approved unanimously.

#### The General Body also passed the following Resolution unanimously.

- a). Resolution to extend full support of the BOBWO, Karnataka to AIBOBECC whenever any call of agitation unleashed by the latter. The General Body also congratulated the leadership of AIBOBECC and other Unions under United forum for making the Management to come to the Negotiating table during the recent agitational steps including strike action proposed on 30.05.2022.
- b). Resolution demanding of the Management to come forward with necessary steps to resolve the problems / grievances presently being faced by the JND Collectors of the Bank.
- c). Resolution demanding of the Management to increase the amount of daily wages to hundreds of temporary employees who are working in the Bank mostly belonging to e-VB in line with the Minimum Wages Act / Bipartite Settlement besides urging upon to absorb them as permanent employees in the Bank through settlement with AIBOBECC at central Office level.
- d). Resolution demanding conversion of all Part Time Employees (Sweepers) into Full Time Employees under Sub-staff cadre.
- e). Resolution demanding adequate recruitment of staff in Award Staff category as the shortage of staff in the Branches has seriously effected customer service at the Branches, in turn, Bank's Business.

#### **Election of Office Bearers / Executive Committee Members**

Com. S D Srinivasan, placed before the General Body a list consisting of proposed names of Office Bearers & Executive Committee members for the ensuing terms as per the approved Bye-laws of the Union for the approval of the delegates.

The list proposed and placed by Com. S D Srinivasan has been approved by the delegates unanimously. The details of the Office Bearers & Executive Committee Members unanimously approved by the General Body is appended to this circular for the reference and information of our members.

The Delegate / Business Session concluded with Vote of Thanks by Com. Mallesha M C, the newly elected General Secretary.

#### **Inaugural Session**

The Inaugural Session of the Conference started at 10.45.a.m. The beautifully decorated spacious hall was jam packed with the presence of our Delegates, Invitees, retied colleagues and Senior Leaders, Leaders and members of other Fraternal Trade Unions functioning in the Bank. It was observed that more number of women delegates participated in the Conference. The programme was compered and compiled by Com. Sutapa Dutta Mondal along with Com. Pooja M and Com. Shruthi C. A befitting, melodious invocation was rendered by Com. Shruthi C. After lighting the lamp and offering flower Tribute to the Founder leaders of AIBEA the proceedings began with welcome address by Com. Though the proposed strike call on 30.05.2022 was deferred due to intervention of the Labour Commissioner Com Janak Rawal called upon the members to be ready for any serious form of agitational steps if the Management do not come forward to resolve our legitimate and genuine demands.

He also congratulated the leadership of BOBWO, Karnataka for their active involvement in the Union responsibilities and also for the wonderful way in which the conference was organized with mammoth participation of Delegates and Invitees. He also wished all success for the future activities of BOBWO, Karnataka.

**Com. S P Sharma,** President, AIBOBECC, General Secretary, AIDBECC, the Guest of Honour to the Conference appreciated the leadership for the massive mobilization of Delegates to the Conference and also for the good arrangement made for successful conducting of the Conference.

He called upon the members to be remained vigilant against anti-employee stances of the Management wherever initiated and also fight effectively against such steps. He also quoted the recently called agitational programme of AIBOBECC and the proceedings held at the office of Dy. Chief Labour Commissioner (Central), Mumbai. He re-iterated that the AIBEA is always known for fight against in- justice both inside and outside the Banking Industry always showing its concern to the well-being of the people at large. AIBEA fought against Anti-Labour Policies unleashed by successive Central Governments from the date of its inception during the year 1946. He also concluded by conveying his greetings and best wishes to all the Delegates and Members of BOBWO, Karnataka for their future functioning.
