**SALIENT FEATURES OF SCHOLARSHIP SCHEME**

1. **Introduction:** The Scheme was introduced in the year 2009 after the decision of the 21<sup>st</sup> General Body Meeting of the Society. In the 26<sup>th</sup> Annual General Body Meeting held on 30<sup>th</sup> September, 2014, it was decided to extend the scholarship to the children of clerical staff also.
2. **Objective:** To encourage and motivate the members of the society to provide better education to their wards. To utilize the common welfare fund of the society for common good cause from out of the profit earned by the society.
3. **Name of the Scheme:** It will be called VIJAYA BANK WORKERS' COOPERATIVE THRIFT AND CREDIT SOCIETY MERIT SCHOLARSHIP SCHEME.
4. The award of scholarship will be on an annual basis for excellence in SSLC and Higher Secondary education.
5. **Quantum of Scholarship:** The amount of reward will be a lumpsum of Rs.4,000/- per candidate.
6. **Eligibility:** Children of the Clerk/sub staff/part-time sweepers in permanent services of the bank, who are members of the society, are eligible to apply.
7. Candidates, who have passed X Standard or XII Standard (SSLC/HSC/PUC) in March/April, 2023, are eligible to apply. Attested copies of the mark sheets should be attached.
8. **Selection:** The applications received by the Society upto the stipulated date will be entertained.
9. The awards are inter-changeable and if sufficient applications are not received, the same may be carried over to next year to extend more cash awards. The discretion, in this regard, is vested with the Board of Directors of the Society.
10. **Other Conditions:**
  - (a) Mark sheets should be attested by the Branch Head.
  - (b) Application should be submitted by the concerned employee giving full details.
  - (c) The right to alter, amend or change the scheme lies with the management of the society.
  - (d) The decision of the society shall be final.
